**Robbery**

On Thursday, September 19, 2013 at approximately 9:15AM, the suspect (see attached bulletin) entered the CVS Pharmacy (9200 Centreville Rd) and handed the pharmacist a note demanding specific narcotics. After receiving the drugs, he fled the scene on foot towards Mathis Ave. He was possibly wearing a fake mustache & beard. The suspect appears to be the same man who robbed the store in a similar manner on April 7 and July 16.

**Narcotics – Arrest**

On Friday, September 13, 2013 at approximately 1:00AM, Manassas City Police, with a warrant, searched a room at the ‘Homestyle Inn’ at 9913 Cockrell Road. The search was part of an investigation of narcotics related activity at the hotel. As a result of the investigation and search, George Michael Murray, 25, of 10150 Community Drive (20109) was arrested and charged with Possession of a Schedule II Controlled Substance (Cocaine). He was taken to the ADC and later released on a secure bond pending an October 22 court appearance.

On Wednesday, September 18, 2013 at 12:02AM, a Manassas City Police Officer conducted a traffic stop near the intersection of Plantation Lane and Braxted Lane for Reckless Driving. The driver of the vehicle, Pascal Trent Jr., ran from the car; but was quickly caught by Officers. Pascal Lee Trent, Jr., 51, of 9540 Buttonbush Court, was arrested and charged with DUI (3<sup>rd</sup> Offense in 5 years), Driving While Revoked (DUI related), and Eluding. He was held at the ADC without bond pending an October 22 court appearance.
