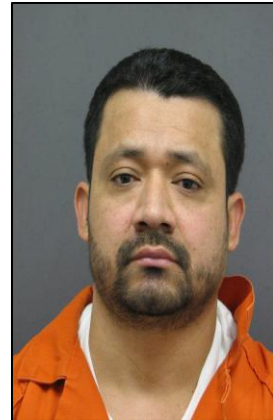
**Larceny from Auto**

On January 15, 2014 Manassas City Police met with a resident on the 8600 block of Point of Woods Dr for a report of a larceny from a vehicle. According to the reporting party, someone(s) stole vehicle parts, a radio, and radio equipment to include an amplifier and subwoofer out of her vehicle sometime during the overnight hours of January 14<sup>th</sup> or morning of the 15<sup>th</sup>. ## **Narcotics Investigation – Arrest**

On January 16<sup>th</sup>, 2014 Investigators from the Prince William-Manassas-Manassas Park Narcotics Task Force concluded a two month-long narcotics investigation involving the selling of cocaine with the execution of a search warrant at 9088 McClellan Commons. During the search, suspected cocaine and an undisclosed amount of U.S. Currency were recovered. Gerzan Zuniga-Calderon, 30, of 9088 McClellan Cmn was taken into custody without incident and charged with three counts of distribution of a schedule I or II narcotic. He was held without bond and his court date is unavailable.
