Suspect Pleads Guilty to Triple Homicide

The suspect in a triple homicide case that originated on the 9200 block of Hood Rd and the 9600 block of Brent St in 2011 pled guilty and was sentenced this morning in Prince William County Circuit Court. On June 18, 2014 the defendant, 40-year-old Jose Oswaldo REYES ALFARO of 9213 Hood Rd, pled guilty to the following:

- 3 counts of capital murder
- 3 counts of malicious wounding
- 5 counts of use of a firearm in the commission of a felony
- 1 count of breaking and entering

REYES ALFARO was sentenced to a total of 7 life sentences, plus 23 years.

TRIPLE HOMICIDE

On February 10, 2011 at approximately 7:15 PM officers responded to the 9200 Block of Hood Rd for the report of a shooting. When officers arrived they discovered a 56 year old female deceased in the front yard suffering from apparent gunshot wounds. Three other victims; 2 adults and 1 juvenile, were also discovered at this residence suffering from apparent gunshot wounds as well.

Approximately 30 minutes later, officers received a call of a 2nd shooting at the 9600 Block of Brent Street. Responding officers discovered a 48 year old male deceased from apparent gunshot wounds inside the residence and a 77 year old female suffering from severe lacerations to her head.

Suspect and vehicle information obtained from witnesses at the Hood Rd shooting scene was broadcasted to surrounding jurisdictions. Shortly after 8:00 PM, Prince William County Police Officers stopped a vehicle matching the suspect's description traveling on Dumfries Rd near Cobb Rd, taking the driver into custody for questioning.

After further investigation by Manassas City Police Detectives, Jose REYES ALFARO has been charged with 3 counts of 1st Degree Murder (court date pending).
