### Commercial Regional Armed Robbery Series

December 22, 2014

At approximately 8:15PM on Tuesday, December 9, 2014, a male subject entered In & Out Mart, located at 8930 Ashton Ave within the City of Manassas, and demanded money from the clerk while pointing a handgun at him. The clerk complied and the suspect fled the scene on foot with an undisclosed amount of cash. He was last seen running towards the Bristoe Station neighborhood.

*Description of suspect:* Hispanic male, approximately 5'5" tall with a thin build and slight beard, wearing a black fishing style hat, black jacket, black pants, and black shoes

The following four robberies, similar in nature, occurred in neighboring jurisdictions and are believed to have been committed by the same suspect.
