Arrest Made in Stevens Ct Shooting Investigation [Oct. 27, 2015]

Martin Allen BOYCE, a suspect in the Sept. 25, 2015 shooting that occurred on the 9100 block of Stevens Ct, was arrested on Oct. 27. BOYCE was charged with Aggravated Malicious Wounding, Use of a Firearm in the Commission of a Felony, and Shooting/Missile into an Occupied Vehicle. BOYCE was held without bond and has a pending court date in General District Court.

Police Requests Public's Assistance in Shooting Investigation [Sept. 30, 2015]

At approximately 1:05AM on September 25, 2015, Manassas City Police responded to the 9100 block of Stevens Ct for a report of a shooting in progress. Once on-scene, officers found one victim who had been shot and critically injured lying outside. The victim, a 24-year-old male victim of Annandale, is still being treated for life-threatening injuries at an area hospital. Manassas City Police would like to thank the public for its patience as Investigators work tirelessly on the case, and for citizens' tips that have provided helpful leads in their investigation.
